## End of Term Report on Budgetary Issues 2017

- 1. This report has been prepared by the ASCOBANS Secretariat, using information provided by the CMS Administrative and Fund Management Unit (AFMU) and the United Nations Office in Nairobi (UNON).
- 2. The report contains figures as recorded in the book-keeping system as at 31 December 2017. The report is presented in Euro, which has been converted from the US dollar figures provided by AFMU/UNON. All figures are rounded to the next full Euro.
- 3. Voluntary Contributions were received in the reporting period as follows: Germany: €25,600 (incl. PSC) for various activities as agreed with the donor

#### Expenditure of the General Trust Fund

- Table 2 below shows the approved budget for 2017 and the status of expenditures on the General Trust Fund for ASCOBANS as recorded in our bookkeeping system at 31 December 2017. A total of € 154,443 was recorded as expenditure in the period January to December 2017<sup>1</sup>.
- 6. A total amount of € 88,756 at the conversion rate used for this report (1 US\$ = € 0,891) was available at the end of 2016 to be carried over into the 2017 budget. Of this amount, €24,668, the 2016 closing balance of all staff lines combined, was carried over to the Administrative Assistant's line (03.04) to cover anticipated extra time required. € 2,390 has been used to cover expenditure exceeding the allocated € 1,800 on the experts travel line.<sup>2</sup> As a consequence, a total of € 61,698 is available for additional activities to be funded from the "Conservation Projects" line. € 1,164 was paid to the Zoological Society of London from this line (SSFA2017\_2) (2<sup>nd</sup> part of existing project, finalised in mid-2017, see AC23/Inf.9.1.a).
