# Mid-Term Report on Budgetary Issues 2018

- 1. This report has been prepared by the ASCOBANS Secretariat, using information provided by the CMS Administrative and Fund Management Unit (AFMU) and the United Nations Office in Nairobi (UNON).
- 2. The report contains figures as recorded in the book-keeping system as at 30 June 2018. The report is presented in Euro, after conversion from the US dollar figures provided by AFMU/UNON. All figures are rounded to the next full Euro.
- 3. Voluntary contributions were received in the reporting period as follows:

Germany: €25,600 (incl. PSC) for various activities as agreed with the donor

### Expenditure and Commitments of the General Trust Fund

- Table 2 below shows the approved budget for 2018 and the status of expenditures on the ASCOBANS General Trust Fund as recorded in the UN bookkeeping system at 30 June 2018. A total of € 94,860 was spent or obligated in the period January to June 2018<sup>1</sup>.
- 6. A total amount of US\$ 118,521 (corresponding to € 105,602 at the conversion rate of 0.891 used for this report) was available in the budget at the end of 2017. The funds were retained in the individual budget lines as illustrated in Doc.18.2.a and carried over within the same budget lines into 2018.
- 7. In June 2018 ASCOBANS was informed by the CMS Administrative Unit through United Nations Office in Nairobi (UNON) that there was an open advance of a total of € 2,405 (see budget line 03.11 below) related to our in-house travel agent Westtours for the DSA payment of five meeting participants at AC22 (29 September 1 October 2015, The Hague, Netherlands). At the time in 2015 the funds had been committed, but were not charged to ASCOBANS, therefore actual DSA payment was retroactively charged in 2018.
