# Update on ASCOBANS/ACCOBAMS cetacean pathology harmonization protocol

#### Context

- At ASCOBANS AC24 two different protocols/best practices for the postmortem analyses on cetaceans were presented.
- Both used a multi-tier approach but needed an harmonization and a coordination in order to develop a unified document outlining European best practice on cetacean necropsy.
- A harmonization workshop, funded by ASCOBANS and ACCOBAMS was organized by Sandro Mazzariol (Italy), Lonneke Ijsseldijk (NL) and Andrew Brownlow (UK) and held 24-25 June 2019 in Padua, Italy.
- 22 invited participants from across Europe undertaking cetacean necropsy and investigations
  - Limited funds, small group to aid discussions



#### Terms of references for the workshop

#### a) Harmonize multi-tier best practice for basic necropsy procedure

AIM: create an accessible document comprising a harmonization of existing post mortem procedures within the two agreement areas

#### b) Setting up diagnostic frameworks for specific threats

AIM: Define and harmonize specific diagnostic approaches and interpretation of findings among the veterinary pathologists and other scientists performing necropsies within the two agreement areas.

#### c) Composing a list of experts/laboratories for technical support and advice

AIM: Provide appropriate contacts for specific issues, methodologies and techniques within the two agreement areas.

# **Key themes from workshop**

- Emphasis that the document is to augment rather than replace existing protocols
- Agreement that consistency was necessary to enable data sharing and this update was needed
- Emphasis that the assessment of the cause of death and health status is a **veterinary procedure** requiring a full post mortem investigation with additional examinations.
- Detailed investigation of fresh carcases by experienced **veterinary pathologists** remains the **gold standard** and an absolute requirement for assessing overall health.
- There is **no shortcut** to a complete and throughout necropsy in order to evaluate and eventually rule out all the possible causes of death.
- Not all networks have that **capacity** however, and strandings networks, run by experienced non-veterinarians, can, and have, operated successfully.
- Collection of data and samples can however be invaluable to gain information on some threats, pollutants and important biological and life-history parameters.
- Sampling and testing should be complete and throughout and interpretation should be based on the best existing literature and protocols available.

## **Final document**

- To provide a reference document for veterinarians and biologists currently engaged in cetacean post-mortem investigation, summarising a recognised approach to stranding investigation across European networks;
- To highlight areas where harmonisation of data from existing networks could allow for analysis and inference to be made between networks, of particular relevance for the transboundary, mobile species;
- Provide a start-up guide for researchers attempting to instigate new stranding monitoring programmes, particularly in regions of the world with limited resources for extensive, top-down surveillance programmes.
