END OF TERM REPORT ON BUDGETARY ISSUES 2022

- 1. This report has been prepared using information provided by CMS Administrative and Finance Management Unit (AFMU). It is an update to the mid-term report 2022 published for the 27th Meeting of the Advisory Committee (September 2022) as <u>ASCOBANS/AC27/Doc.18.3</u>.
- 2. The report contains figures as recorded in the enterprise resource planning system 'Umoja' from 1 January to 31 December 2022. The report is presented in euro, which has been converted from the US dollar figure reports generated from Umoja and cleared by AFMU. All euro figures are approximations due to variations in the exchange rate between euro and US dollar. All figures are rounded to the next full euro.
- 3. Voluntary contributions were received as follows:
 - Germany € 25,600 for supporting the long-term coordination of the ASCOBANS harbour porpoise action plans, developing the AC27 report, and developing guidelines for cetacean-friendly marine spatial planning).
 - Finland € 5,000 for co-funding the long-term coordination of ASCOBANS harbour porpoise action plans.
 - Germany € 30,510 for the expert workshop to recommend small cetacean conservation objectives in relation to anthropogenic removals.

Income to the General Trust Fund

4. Assessed contributions for 2022 were all paid to the ASCOBANS General Trust Fund. Table 1 below shows contributions as of 31 December 2022. Pledges are based on Annex 2 of Resolution 9.6.

Expenditure of the General Trust Fund

5. The below table shows the approved budget for 2022 (as per Resolution 9.6) and the expenditures as recorded in Umoja as of 31 December 2022. The table also factors in the carry-over from 2021 of € 115.341.

6. A total expenditure of € 243,011 has been reported for the period January to December 2022. Factoring in the carry-over from 2021 of € 115,341, a total amount of € 100,703 was subsequently available at the end of 2022 and was rephased into the year 2023.
