





1.3 International cooperation

In addition to fishermen's organizations, involvement of regional managers as well as conservation-oriented end users is important, not only to improve data collection, knowledge/information sharing, joint methodology, and indicator development, but also for efficient use of human and financial resources. Therefore, effective cooperation with the following conservation and regional seamanagement organisations should be secured: ACCOBAMS, ASCOBANS, GFCM, HELCOM, NAMMCO, NEAFC, OSPAR, RCGs, and other RFMOs and RSCs.


